MINUTES

Academic Council Chair Dr. Jack Angello called the meeting to order at 1:10 pm in the V-108 Drafting Classroom. Members present were Dr. Jack Angello (representing Continuing Education, Ed Zehr (representing Instruction), Jim Holan (representing Instruction), Alice King for Debbie Raumakita, (representing Instruction) and Chas Algaier, Vice-Chair (representing the School of Education). Vince Riley was present as recorder. Randall Nelson was present to present the Course Guides for the Technical Trades/Apprenticeship program.

1. Review and adoption of agenda for today's meeting:

ACTION #1: It was moved, seconded and unanimously approved to accept the Agenda.

2. Review and adoption of minutes of previous meetings:

No minutes of Academic Council meetings on 10/01/99 and 10/29/99 were available to the Council, so this item was postponed to the next meeting.

3. Curriculum Action Requests (Course Guides):

A number of Course Guides for Vocational Education courses have been readied for review by the Academic Council:

ACTION #2: The Course Guide for ET 151 was examined, and approved, with modifications, unanimously. Similar modifications were required for the other Vocational Education Course Guides, so Randall Nelson was requested to revise the other Course Guides accordingly, for resubmission.

Randall Nelson also introduced new Vocational Education Course Guides on Building Codes to the Academic Council: BC 100, BC 120, BC 130. There is a need for these courses on Saipan since building inspectors and contractors, architects, and engineers involved in commercial and residential construction on Saipan must constantly be updated on building codes and the periodic revisions thereto.

ACTION #3: The Course Guide for BC 100, BC 120, and BC 130 were examined and returned with the other Vocational Education Course Guides to Randall Nelson for revision and subsequent resubmission.

4. Old Business:

a. The Memorandum of Agreement between the Department of Public Safety and NMC "to implement a program of training for DPS recruits" was reviewed by the Council. It was noted that the actual certification and degree programs, and the number or type of courses required, are not specified in the MOA. It was also noted that the Program Committee of the Board of Regents would meet that same day, and might approve the Basic Police Certificate. The Academic Council could then entertain representations regarding the Basic Police Certificate.

ACTION #4: The Academic Council approved the Memorandum of Agreement between DPS and NMC.

- **b.** An update was provided on the A.A.S. program in Natural Resources Management. It still requires some report of Board approval.
- c. Regarding the "UW" symbol on transcripts, the AC Chair shared results and comments from the survey he had conducted over the Local Area Network. It was also noted that page 16 of the current (1998-99) catalogue states that "failure to withdraw officially from a course will result in a grade of "F" being entered on a student's permanent academic record," while on p. 18 it is stated that "This [UW] symbol is recorded on the transcript when a students fails to officially withdraw from a course within the allowable period. A 'UW' received earns 0 grade points for the course."

ACTION #5: It was moved seconded, and unanimously approved that the Dean of Student Services clarify the contradiction between instructors' varying perceptions that "UW is a failing grade" and "UW is only a symbol, and is not counted in the G.P.A."
