Academic Council Chair Glenn Keaton called the meeting to order at 1:05 pm.

The council moved, seconded and unanimously approved to recommend the Curriculum Action Request/Course Guide for **LI 250 “Literature of the Pacific”** with pending changes.
  - b) NDU grading policy

The council discussed the outcome of the Deliberations Council meeting on NDU grading policy. It was mentioned that the DC decided that an “F” grade in NDU courses should not affect students’ GPA because it is not a credit course and that its grading system should be a Pass or No Pass with a progress report. In addition, if a student deserves an “F” grade then this student will receive such grade in the department and student copy file but not in Admissions and Records file. Some council members favor the “F” grade affecting GPA to prevent students from taking advantage of scholarship benefits when they are not giving effort to succeed in class. A comment was made that NDU grades are not computed into probationary status, so if this is the case then giving an “F” grade will not affect students’ GPA requirement for scholarship eligibility.
