The general purpose of the program is to promote underrepresented minority students in the science and mathematics area. It assists each student in obtaining his or her baccalaureate degree in science, technology, engineering, and mathematics by offering a scholarship of \$40,500 per student per year (the student must attend an institution that participates in the LSAMP Program). The Sciences, Mathematics, Health & Athletics Department has been a part of the program for 4 years. The program allows the department to hire science lab aides (work-study students), purchase books, and pay for a student's airfare to related conferences and the institution which the student will be attending.
