**Nature of the Position:**

Under the direct supervision of the Administrative Director of Information Technology, the incumbent will provide administrative support for the Information Technology Department.

**Duties and Responsibilities:**

- Participates in Program Review and Outcome Assessment (PROA) activities
- Provides high-quality customer service.
- Assist the Administrative Director by coordinating office services with other sectors of the College;
- Prepares miscellaneous correspondence, forms, reports, and other documents as required and requested by the Administrative Director;
- Serves on various department committees; prepares agendas, takes and compose minutes;
- Makes copies of and assembles department correspondence and other printed matter for distribution or processing;
- Maintains office files and department documents;
- Confers with the Administrative Director and department personnel on appointments, meetings, special events, and other scheduled activities, and provides necessary assistance;
- Responds to routine moderately complex questions concerning IT or College policies, processes, or procedures;
